I understand that the rented mountain bike is not to be ridden after dusk and agree to reimburse Keweenaw Mountain Lodge for any theft, loss, or damage, other than reasonable wear and tear resulting from normal use.

I further realize that falls and collisions which may cause injuries or death can occur.

I AGREE TO RELEASE FROM ANY LEGAL LIABILITY, INDEMNIFY, DEFEND, HOLD HARMLESS, AND NEVER SUE Keweenaw Resort LLC, the Copper Harbor Trails Club, special event organizers, sponsors, and all of their successors, heirs, assigns, directors, officers, partners, investors, shareholders, members, agents, employees, owners, landowners, parent and subsidiary companies, and affiliated bike companies for any injury or damage to persons or property, including myself, which may result from the use of the Keweenaw Mountain Lodge trails, facilities, including the pump track, bike wash, tool station and shuttle transportation, to the fullest extent allowed by law, including negligence. I agree that Keweenaw Mountain Lodge has no duty to supervise my conduct, that of others or to maintain any bicycling surface.
