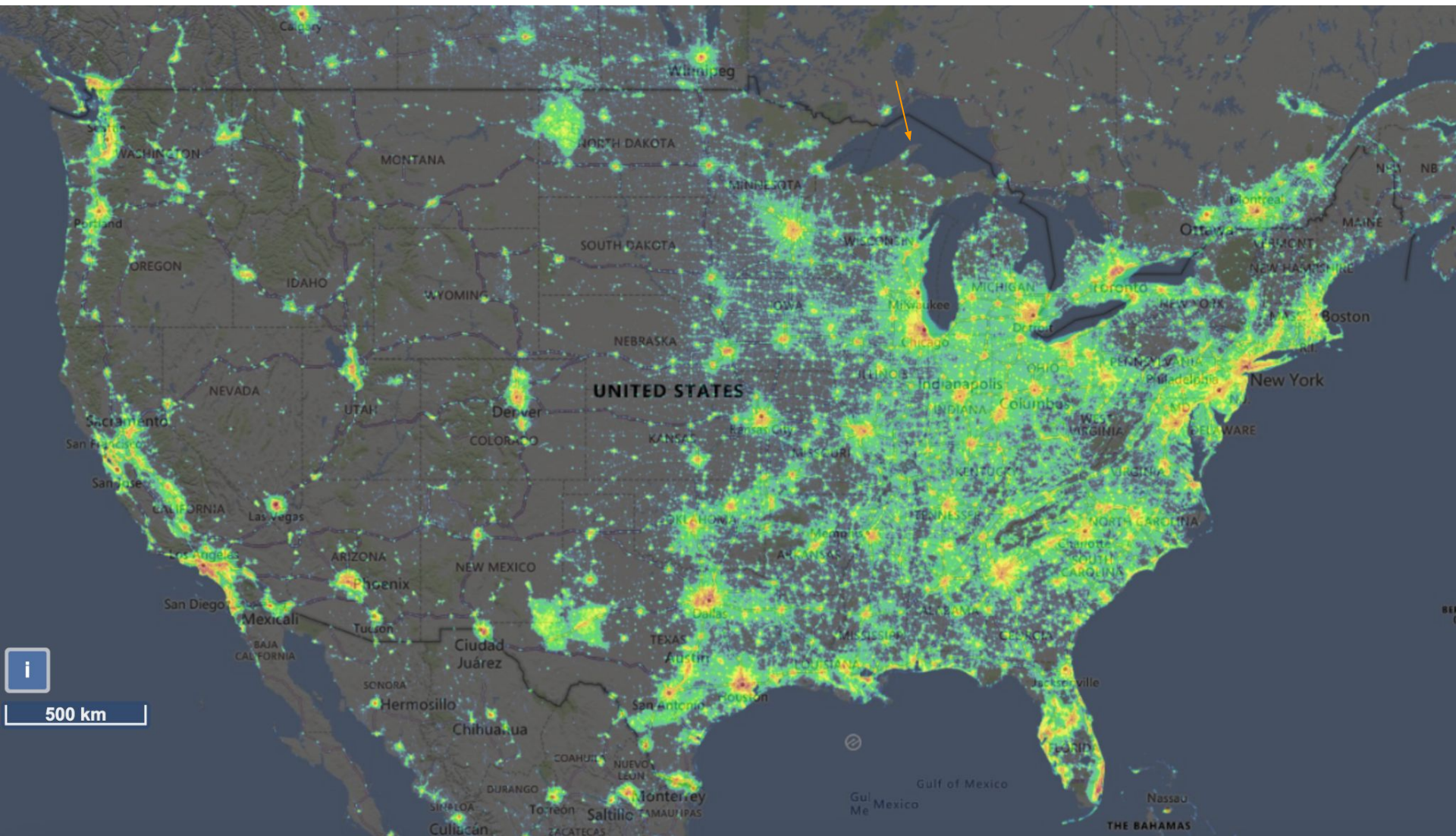






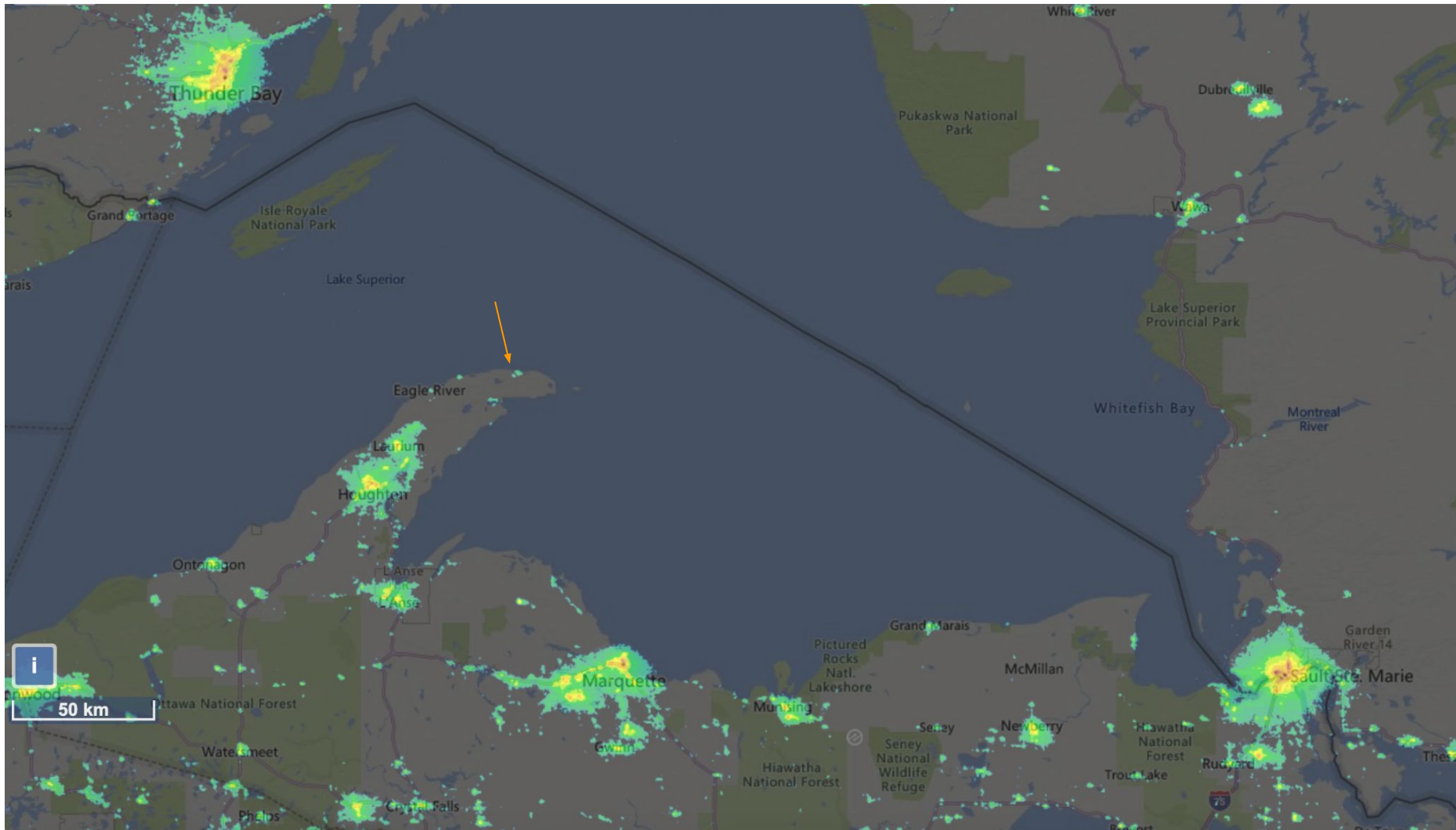


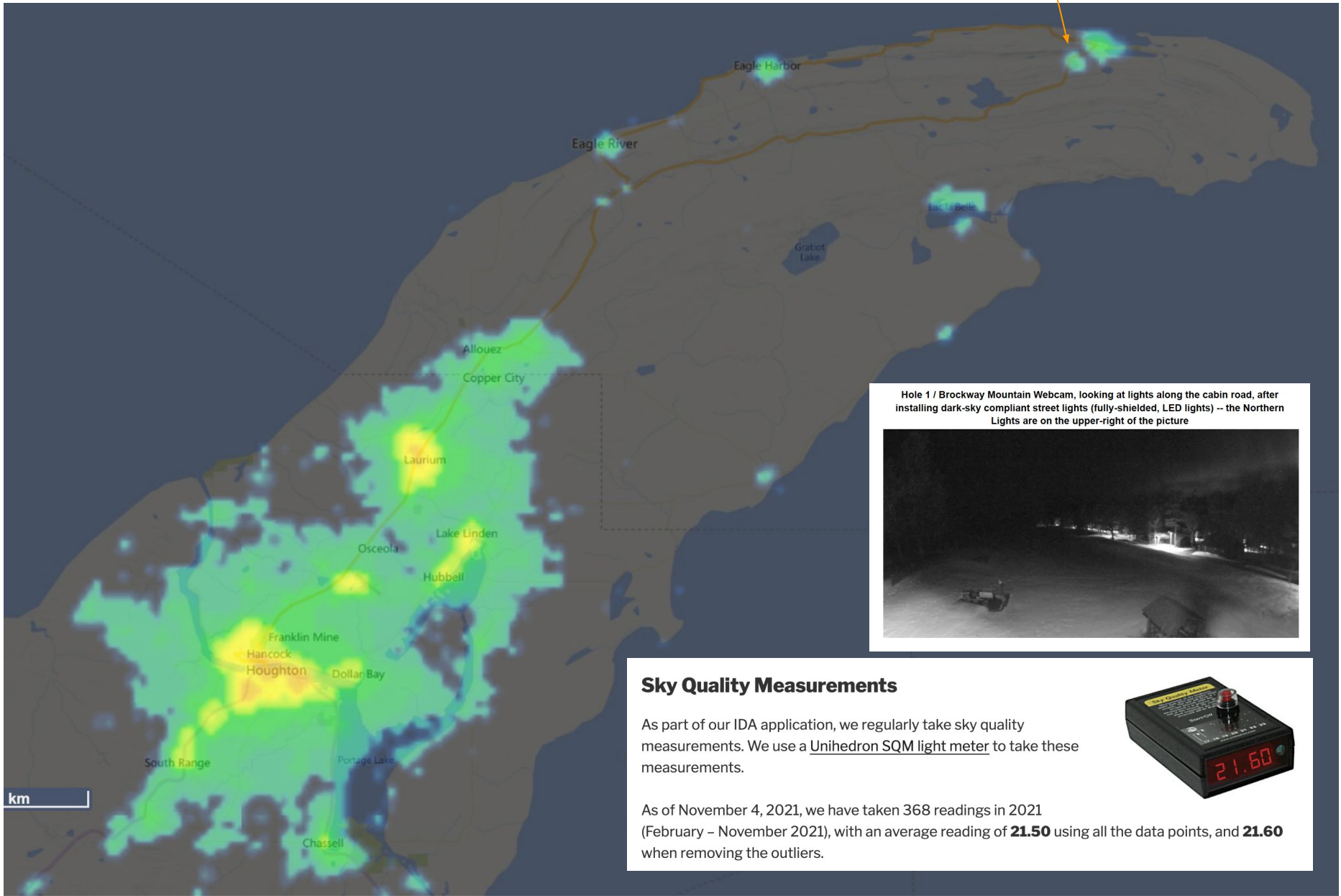

Sky Quality Measurements

As part of our IDA application, we regularly take sky quality measurements. We use a Unihedron SQM light meter to take these measurements.



As of November 4, 2021, we have taken 368 readings in 2021 (February - November 2021), with an average reading of **21.50** using all the data points, and **21.60** when removing the outliers.

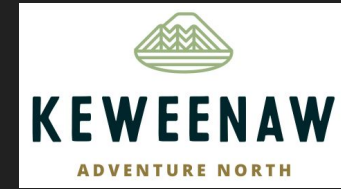

The benefits of dark skies are:

- Improve one's circadian clock (or rhythm) — sleep patterns, hormone release, eating habits and digestion, and body temperature; for good health, we need sunshine as well as darkness
 - [i.e. better circadian clock means a better sleep, which contributes to better overall health]
- Improving ecological integrity — many plants, wildlife, and insects rely on darkness to forage, breed and navigate, thus dark skies help them survive.
 - [e.g. many birds migrate at night, and the top of the Keweenaw is one of their byways]
- Ensuring the full enjoyment of a wilderness experience

Keweenaw Dark Sky Park Designated as an International Dark Sky Park

As the headquarters for the Keweenaw Dark Sky Park, the Keweenaw Mountain Lodge leads the effort in the region to foster the dark skies.

Copper Harbor, Michigan

The International Dark-Sky Association (IDA) has named Keweenaw Dark Sky Park (KDSP) the newest addition to the International Dark Sky Places (IDSP) Program. The headquarters for the dark sky park will be at the Keweenaw Mountain Lodge (KML), where visitors and supportive community members can meet, learn, and look U.P. to the stars for inspiration and to get closer to nature, while traveling around the top of the Keweenaw peninsula. The park becomes the 3rd IDA-certified Dark Sky Park in the State of Michigan, joining the Headlands International Dark Sky Park and the Dr. T.K. Lawless International Dark Sky Park; and is the first International Dark Sky Park in the Upper Peninsula of Michigan.

“Keweenaw Dark Sky Park offers a unique experience to stargazing in the Midwestern United States,” stated Ashley Wilson, IDA’s Director of Conservation. “The historic wilderness lodge allows visitors to view the magnificence of the night sky in a window of the pristine boreal landscape while also having the opportunity to further engage with the nocturnal environment with astrophotography and lighting management workshops.”

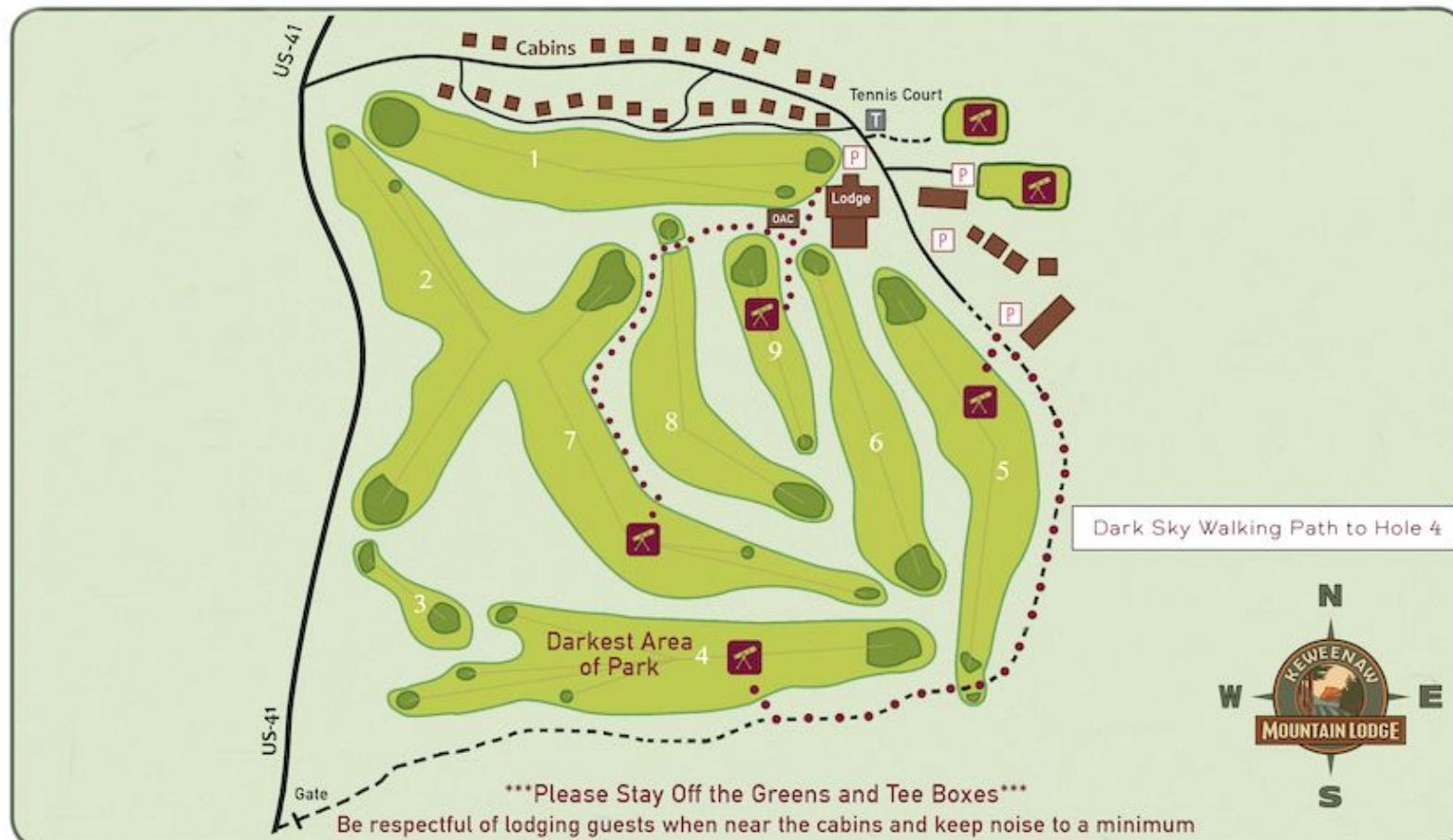

Keweenaw Dark Sky Park Night Sky Viewing Area



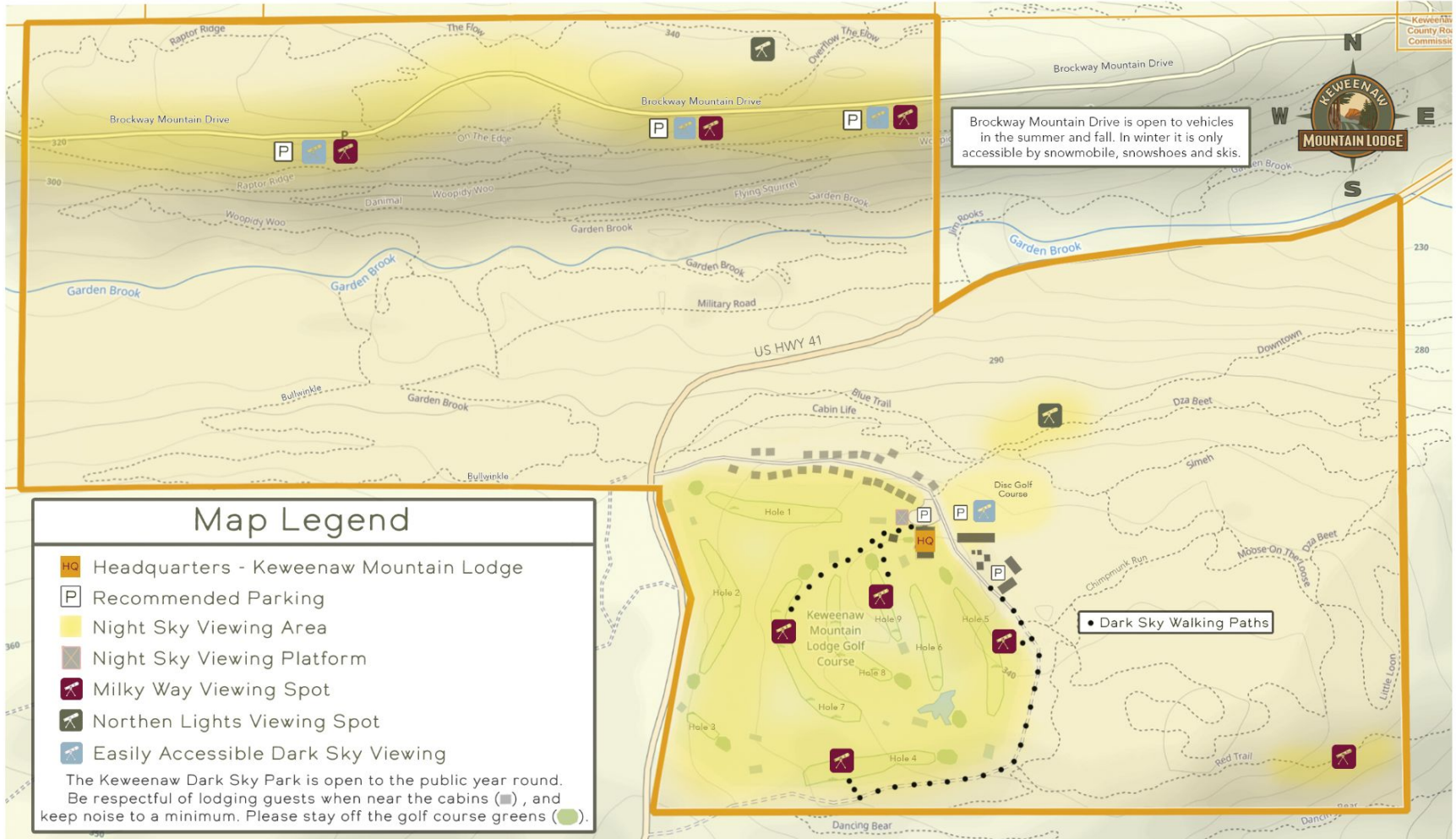

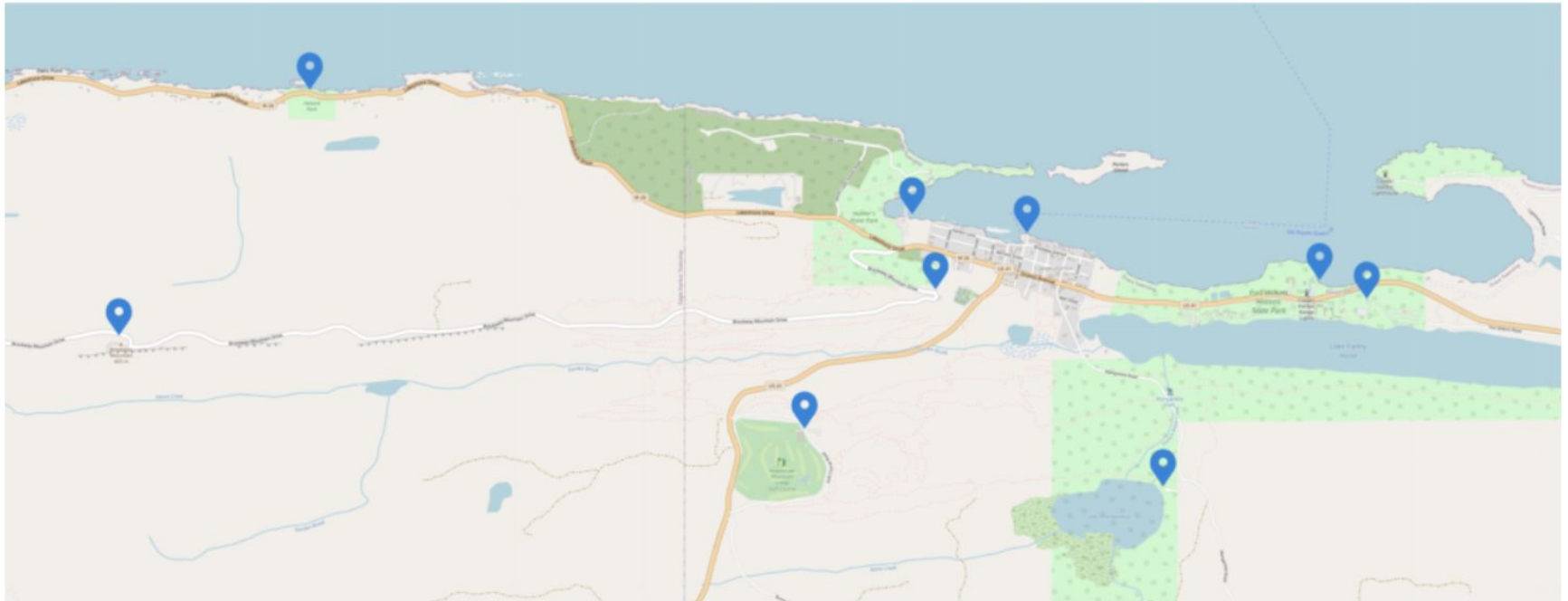

Surrounding Areas

At the top of the Keweenaw, there are not very many areas that are developed. This offers stargazers multiple locations to look up and see the stars. This includes places along the Lake Superior lake front (on M-26 and US Hwy 41), in multiple county and state parks, and up Brockway Mountain; all of which are just a short jaunt away from the Lodge. 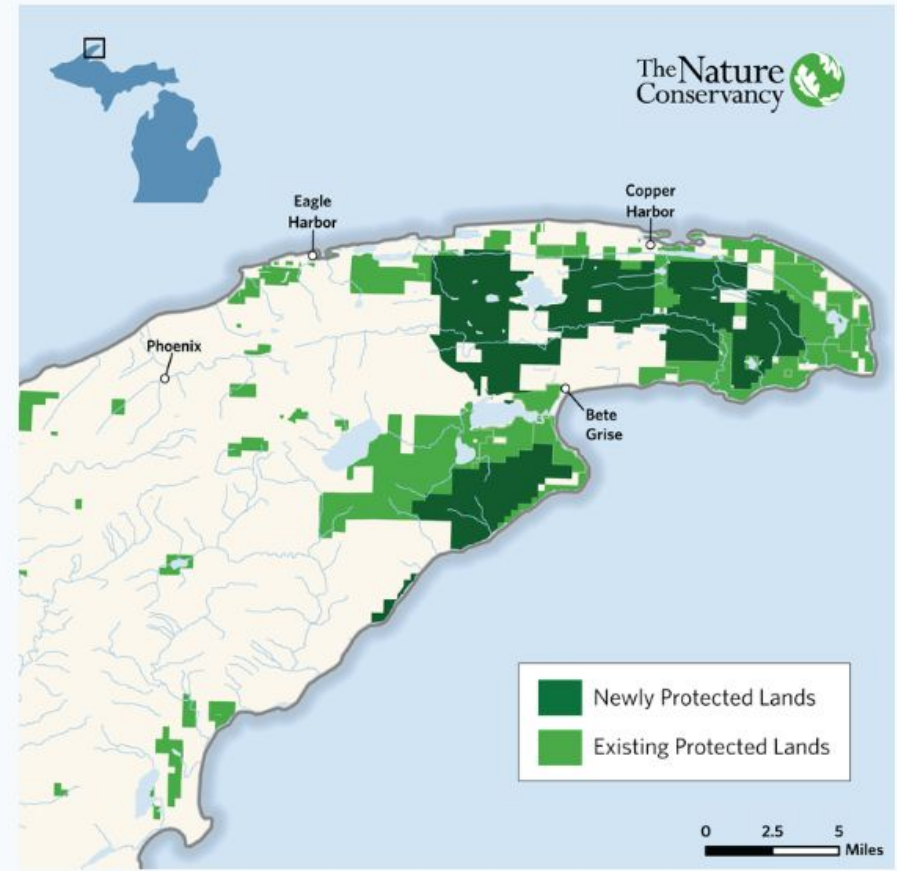
WHAT IS THE KEWEENAW HEARTLANDS PROJECT?

In late 2022, [The Nature Conservancy in Michigan \(TNC\)](#) announced the purchase of approximately 32,600 acres of working forestland near the tip of the Keweenaw Peninsula in Keweenaw County, known as the Keweenaw Heartlands. This purchase from The Rohatyn Group was completed with the support and input of community leaders, the Michigan Department of Natural Resources (DNR) and many people who love the Keweenaw.

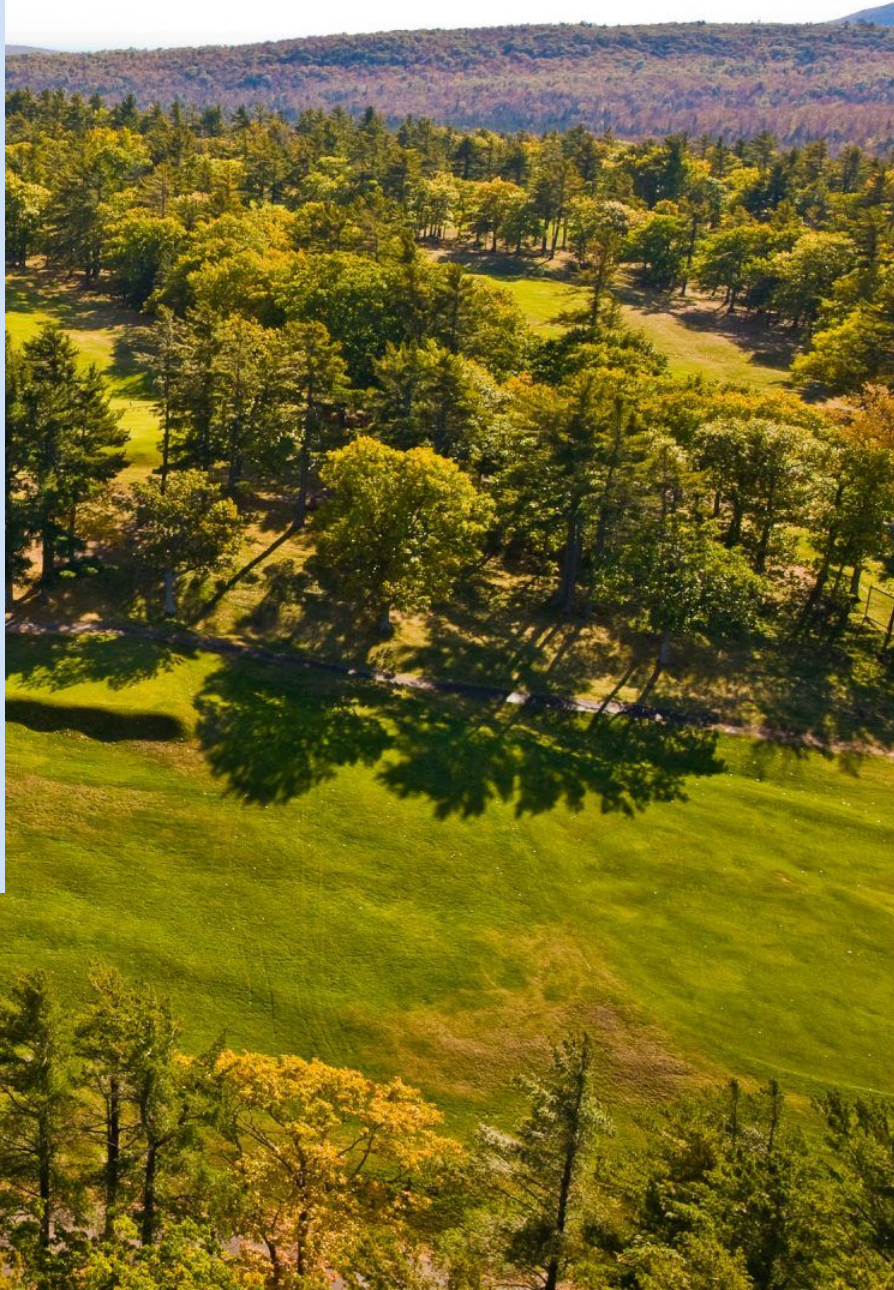
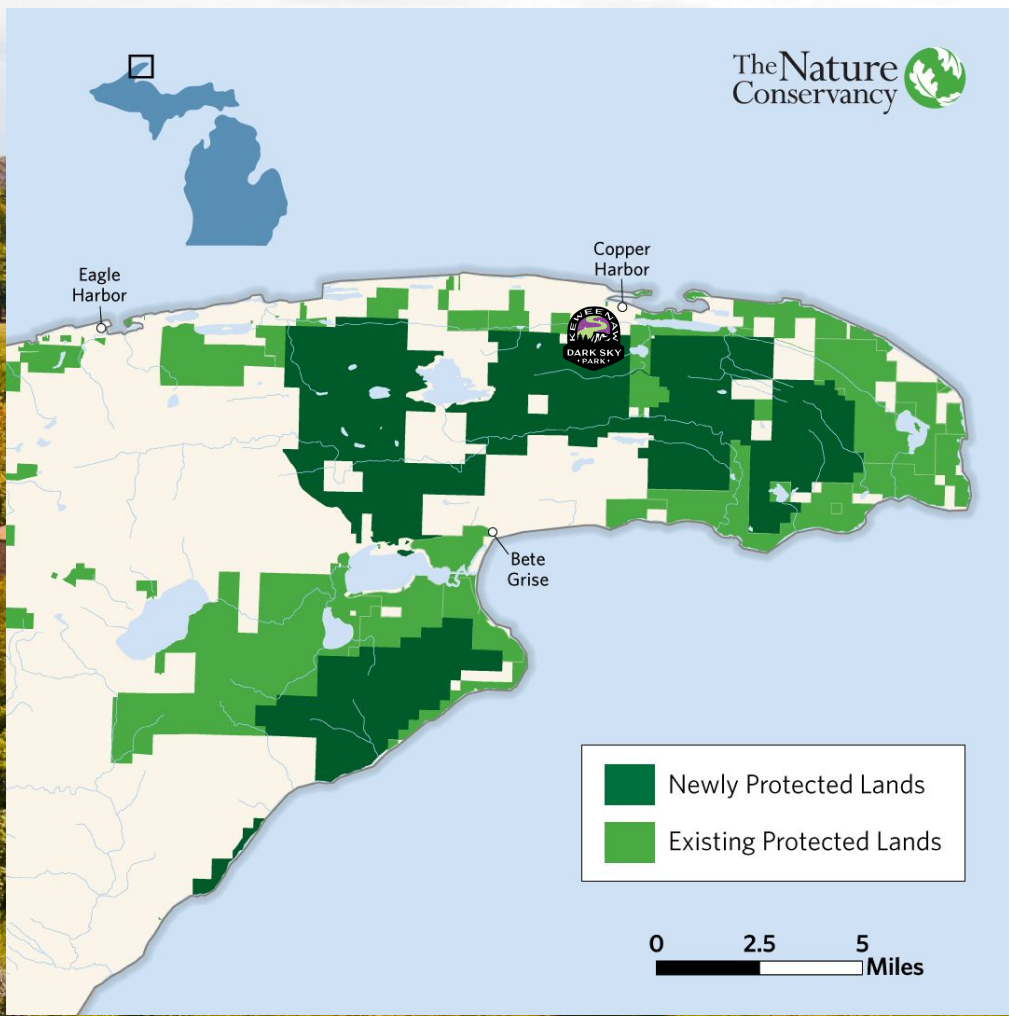
TNC and DNR have convened a planning committee to develop a long-term governance and management plan for the Keweenaw Heartlands. As the interim owners while these plans for the property are developed, TNC will steward the property and lay the foundation for its continued conservation and sustainable use as part of a resilient Keweenaw community.

These lands help define the identity of Keweenaw County and its residents. They contain many sites of [unique ecological, historic, cultural and scenic beauty](#) that help make the peninsula so beloved by the thousands who live and visit here.

Through this project, the Keweenaw Heartlands will be sustainably managed and kept available for the public to access and enjoy for generations to come.

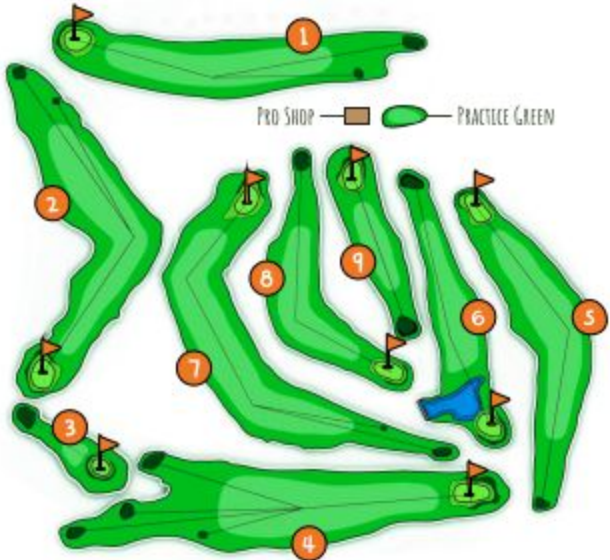

The Keweenaw Mountain Lodge is working toward becoming an Audubon International Cooperative Sanctuary Golf Course. We are currently in the early stages of this process.

The Audubon Cooperative Sanctuary Program for Golf is an education and certification program that will help us maintain our golf course to protect our environment and preserve the natural heritage of the game of golf. The program will assist us “to take stock of its environmental resources and any potential liabilities, and then develop a plan that fits its unique setting, goals, staff, budget, and time.” — Audubon International

As part of our IDA application, we regularly take sky quality measurements. We use a Unihedron SQM light meter to take these measurements.



As of November 4, 2021, we have taken 368 readings in 2021 (February – November 2021), with an average reading of **21.50** using all the data points, and **21.60** when removing the outliers.

Magnitudes per Square Arc Second. Magnitudes are a measurement of an object's brightness. Measuring sky brightness.

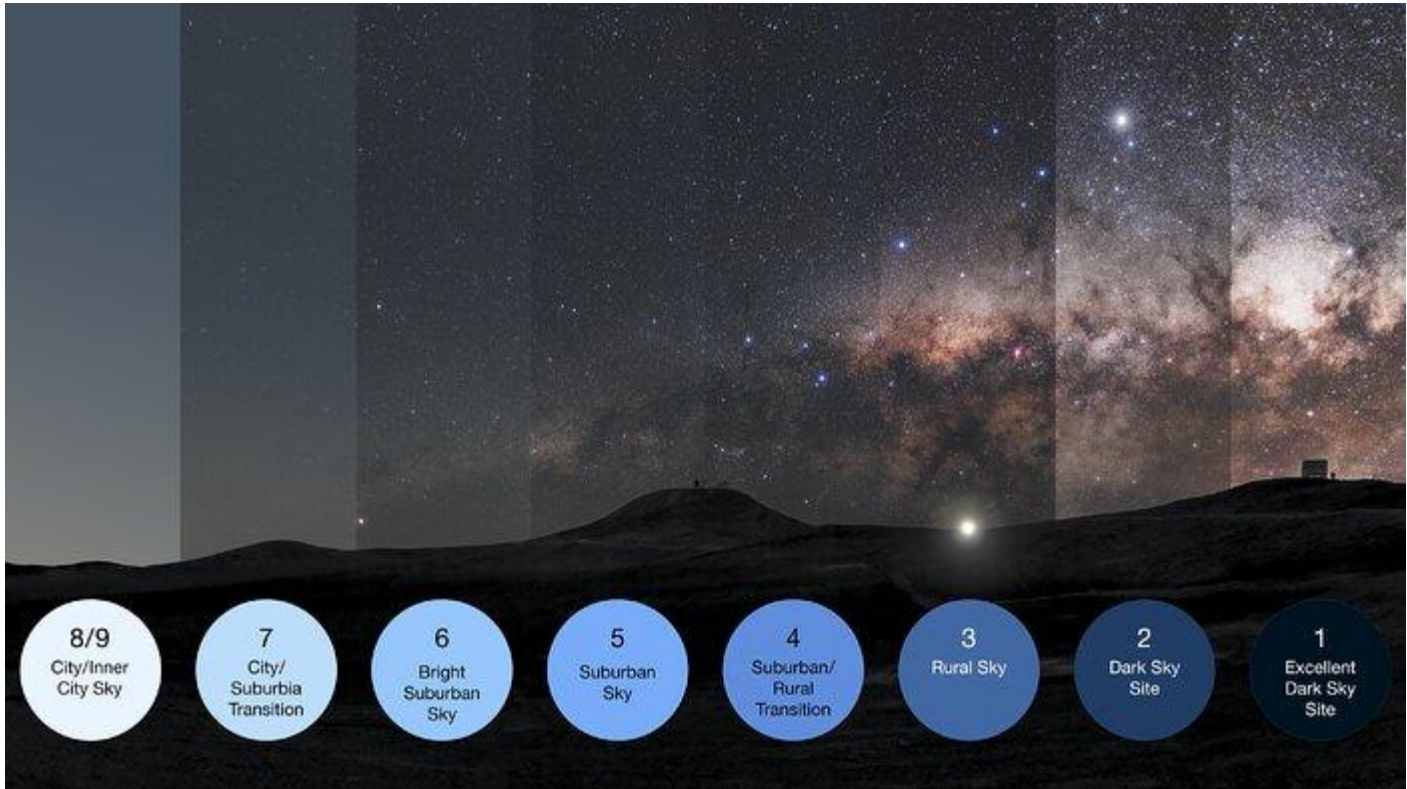
Another measurement Bortle Scale – estimate sky brightness and interpret how light pollution is affecting your view of night sky phenomenon. The lower the number is, the better sky quality. We are a 1 or 2 at the dark sky park.

Part of determining the sky quality is to understand if there are any light dome effects in the vicinity. This requires taking horizon photos. Below is a horizon image which was taken from hole 4 on the property on December 12, 2021 between 2:25am and 4:05am ET (taken by KML team member, Tom Oliver). This image is a spherical panorama merge of 24 photos.

On the night these photos were taken the temperature was 28°F, with a relative humidity of 81%. Winds were SSW 15 knots, gusting to 30 knots. Moonset was at 01:40 EST moonrise was 14:09 EST. Astronomical twilight began at 6:38 and ended at 18:52. The camera used to take the images was a Canon 7D Mark II, with Canon EFS 17-55mm lens [@17mm (w/ sensor 1.6x crop factor = 27.2mm). The camera details and settings are as follows:

- First version submitted on April 22, 2021, fourth (last) version submitted on April 22, 2022 (Earth Day).
- Revise and resubmit process, similar to academic journals / scholarly research.
- Projects page – showing the process
- Worked with 3 program managers, and now Amber has taken the lead – our point person at IDA.
- Annual reports, SQM readings, regular improvements

There is one item that Ashley Wilson is still working to get clarity on before we start to work on the updates to the application (*guidelines for a for-profit company to manage a dark sky park*)
- **January 20, 2022:** The Dark Sky Places Committee reviewed our application, and Ashley Wilson is formulating their response
- **December 25, 2021:** Received confirmation that our application is complete and will be reviewed by the Dark Sky Places Committee at their January 20, 2022 meeting
- **December 15, 2021:** Submitted version 3.0 of application to our IDA program manager Ashley Wilson, with "ver 3.0 change log"
- **December 14, 2021:** Online Meeting with IDA program manager, Ashley Wilson, to review the latest draft of version 3.0 and answer additional questions about the updates.
- **November 29, 2021:** Online Meeting with IDA program manager, Ashley Wilson, to go through her review and discuss updates for version 3.0.
- **November 8, 2021:** Received feedback on version 2.1 of our application from our IDA program manager, Ashley Wilson
- **October 9, 2021:** Submitted version 2.1 of application to our IDA program manager Ashley Wilson, with "ver 2.1 change log"
- **October 1, 2021:** Submitted version 2.0 of application to our IDA program manager Ashley Wilson
(our program manager changed, as John Barentine has left the IDA as of August)
- **May 29, 2021:** Received feedback on version 1.0 of our application from our IDA program manager, John Barentine
- **April 22, 2021:** Submitted version 1.0 of application on Earth Day to our IDA program manager, John Barentine

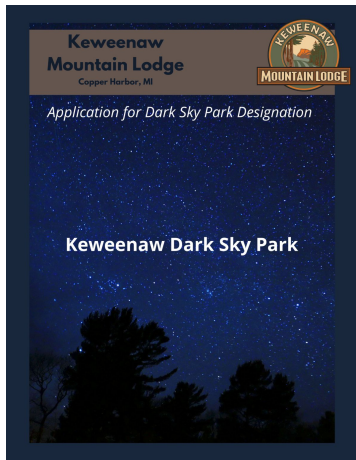

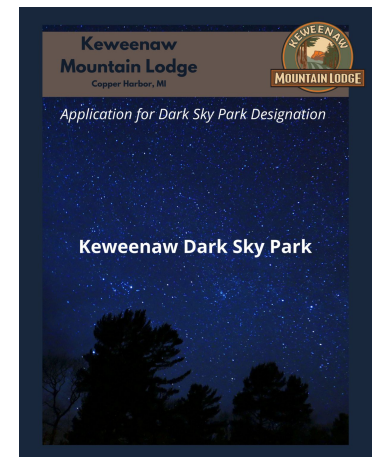



- Provide a safe observing area for dark sky viewing where the public can enjoy the beauty of the stars.
- As part of our education and outreach initiatives, we will work with individuals and organizations in the area to educate them about what we have learned regarding artificial lighting as it relates to dark skies.

Visitor Lighting

The use of auxiliary lighting at night can detract from a guest's experience. When walking around the property at night, guests are advised to use red light, and to shine the light towards the ground in order to not hinder the stargazing experience of others. 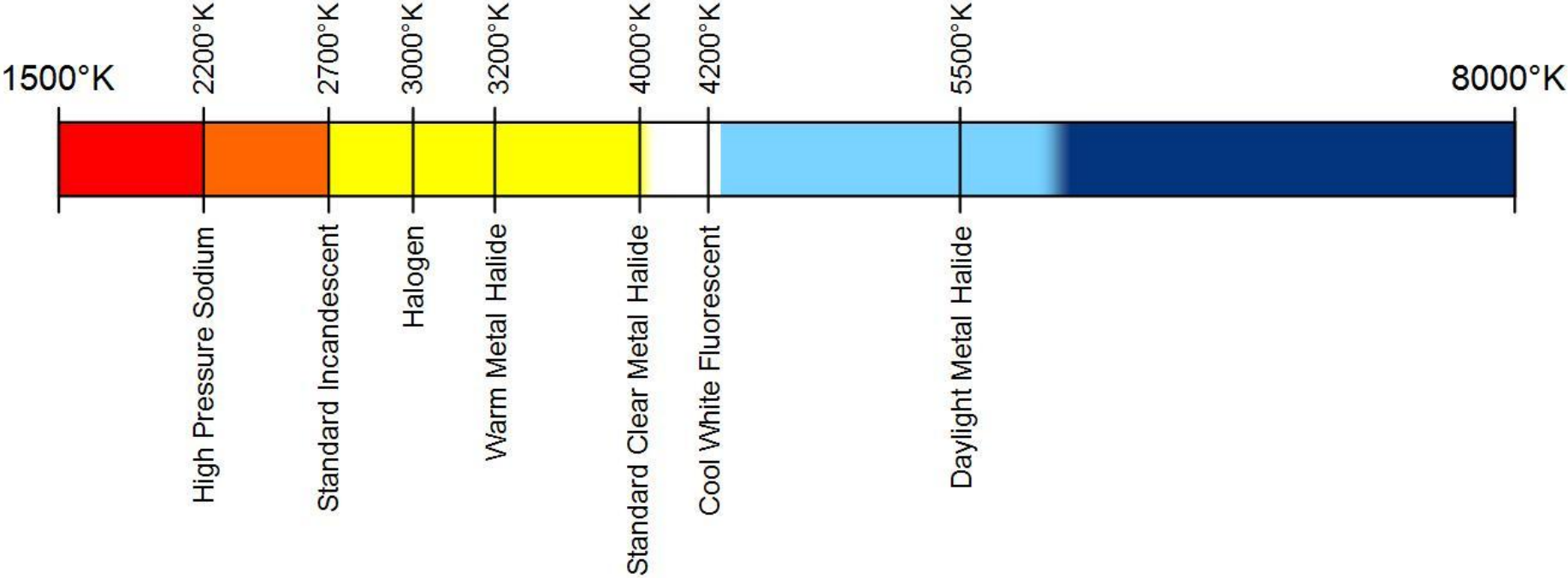

The Leave No Trace Seven Principles



PLAN AHEAD AND PREPARE

- Know the regulations and special concerns for the area you'll visit.
- Prepare for extreme weather, hazards, and emergencies.
- Schedule your trip to avoid times of high use.
- Visit in small groups when possible. Consider splitting larger groups into smaller groups.
- Repackage food to minimize waste.
- Use a map and compass to eliminate the use of marking paint, rock cairns or flagging.



TRAVEL AND CAMP ON DURABLE SURFACES

- Durable surfaces include established trails and campsites, rock, gravel, dry grasses or snow.
- Protect riparian areas by camping at least 200 feet from lakes and streams.
- Good campsites are found, not made. Altering a site is not necessary.
- In popular areas:
 - Concentrate use on existing trails and campsites.
 - Walk single file in the middle of the trail, even when wet or muddy.
 - Keep campsites small. Focus activity in areas where vegetation is absent.
- In pristine areas:
 - Disperse use to prevent the creation of campsites and trails.
 - Avoid places where impacts are just beginning.



DISPOSE OF WASTE PROPERLY

- Pack it in, pack it out. Inspect your campsite and rest areas for trash or spilled foods. Pack out all trash, leftover food and litter.
- Deposit solid human waste in catholes dug 6 to 8 inches deep, at least 200 feet from water, camp and trails. Cover and disguise the cathole when finished.
- Pack out toilet paper and hygiene products.
- To wash yourself or your dishes, carry water 200 feet away from streams or lakes and use small amounts of biodegradable soap. Scatter strained dishwater.



LEAVE WHAT YOU FIND

- Preserve the past: examine, but do not touch cultural or historic structures and artifacts.
- Leave rocks, plants and other natural objects as you find them.
- Avoid introducing or transporting non-native species.
- Do not build structures, furniture, or dig trenches.



MINIMIZE CAMPFIRE IMPACTS

- Campfires can cause lasting impacts to the environment. Use a lightweight stove for cooking and enjoy a candle lantern for light.
- Where fires are permitted, use established fire rings, fire pans, or mound fires.
- Keep fires small. Only use sticks from the ground that can be broken by hand.
- Burn all wood and coals to ash, put out campfires completely, then scatter cool ashes.



RESPECT WILDLIFE

- Observe wildlife from a distance. Do not follow or approach them.
- Never feed animals. Feeding wildlife damages their health, alters natural behaviors, and exposes them to predators and other dangers.
- Protect wildlife and your food by storing rations and trash securely.
- Control pets at all times, or leave them at home.
- Avoid wildlife during sensitive times: mating, nesting, raising young, or winter.



BE CONSIDERATE OF OTHER VISITORS

- Respect other visitors and protect the quality of their experience.
- Be courteous. Yield to other users on the trail.
- Step to the downhill side of the trail when encountering pack stock.
- Take breaks and camp away from trails and other visitors.
- Let nature's sounds prevail. Avoid loud voices and noises.

Nurturing and Fostering Quiet

One of the best compliments we get when people stay at the lodge is how quiet and peaceful it is, and that they were able to get the best night of sleep in a long time.

To help quantify and formalize the quietness at the resort, we are talking with Quiet Parks International about becoming a Quiet Parks Quiet Stay resort. Quiet Parks International is an organization that works to foster quiet areas around the world. This is important to us as our guests come from urban areas and want a getaway that is calm and quiet in the wilderness. This gives them the ability to restore their balance in silence and nature.

We are in communication with Vikram Chauhan at Quiet Parks International, and working on an application to be certified as a quiet park. This will give us the ability to host quiet experiences (quiet stays, quiet retreats) and provide education about the benefits of quiet [Initial communication with Vikram Chauhan, February 2022]
